**MINIMUM QUALIFICATIONS:**

- Bachelor's degree in Mathematics, Physics, Chemistry, Computer Science, Statistics, and Geography from a U.S. accredited institution or foreign equivalent.
- Willing to learn numerical modelling Storm Water Management Models (SWMM) and computer programming (such as R, Python, MATLAB).
- Ready to assist with computer-instrument interface methods in obtaining field hydrologic survey information.

**QUALIFICATIONS REQUIRED:**

Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

1. A high school diploma; or
2. Successful completion of General Education Development (GED) Test; or
3. The equivalent of a general education high school program; or
4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

**KNOWLEDGE, ABILITIES, AND/OR SKILLS:**

Must be reliable and well organized. Ability to maintain accurate record keeping and data transcribing. Must be computer literate. Ability to prepare spreadsheet data compilation.

**CHARACTER OF DUTIES:**

Under the direct supervision of Dr. Yeo, the Research Assistant II will assist in all aspects for developing storm water management models (SWMM). This will include related tasks such as collecting geographical information system (GIS) shape files, field works with model ArcGIS App, and manage database for the collected data. Willing to learn computer programming languages (such as R, Python, MATLAB Visual Basic .NET) for managing huge hydrologic data sets efficiently. Willing to publish manuscript to scientific journals related to hydrologic system. Will be ready and available when scheduled to assist with technical field instruments and applications for collecting hydrologic survey information.

**EDUCATION:**

Applicants claiming degrees or credit hours are required to have an original or certified copy of the documents (e.g. transcripts, high school diploma or GED certification) accompany the application.

**WORK ELIGIBILITY:**

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (e.g. previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory

basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

### **POLICE AND COURT CLEARANCE:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.


