**Question 1:** Relative to Item 1.a, specification for "Rack-Mountable and include rack-mounting accessories," please clarify whether the unit will be mounted in a two or four post rack.

**Answer:** **UOG states: The rack-mountable UPS will be to a 4-post rack.**

**Question 2:** Relative to Item 1.a specification for "Maximum Depth: 18 inches," will UOG accept a maximum depth of 18.5 inches?

**Answer:** **UOG states: We will accept 18.5 inches.**

**Question 3:** Relative to Item 1.f, specification for "Surge energy rating:459 Joules," joules is not a metric certified for use by ANSI & IEEE. Will UOG accept a solution that conforms to ANSI C62.41 Category B?

**Question 4:** Relative to Item 1.g, specification for "Operating Elevation: 0-10,000 feet," will UOG accept a solution with a maximum operating elevation of above 9,000 feet?

**b). Extended Price refers to Grand Total. Please indicate the total amount of all items in the designated box.**

**Question 11:** Please confirm the purchase quantity for Bid Item 1, Rack Mounted UPS.

**Answer:** **UOG is requesting 5 Rack Mountable UPS.**

**Question 12:** Please confirm the purchase quantity for Bid Item 2, Standalone UPS.

**Answer:** **UOG is requesting 15 Standalone UPS.**

**Question 13:** Please confirm the purchase quantity for Bid Item 3, Distribution/Aggregation Switch.

**Answer:** **UOG is requesting 2 Aggregation Switch.**

**Question 14:** Please confirm the purchase quantity for Bid Item 4, Edge/Access Switch.

**Answer:** **UOG is requesting 5 Edge Switches.**

**Question 15:** Please confirm the purchase quantity for Bid Item 5, Outdoor Network Point-to-Point System.

**Answer:** **UOG is requesting for 1 set of a point-to-point system. This would mean the bidder would supply 2 units.**

**Question 16:** Exhibit B includes a field for "Grand Total." Is this an all-or-none IFB?

**Answer:** **UOG states: This is an all-or-none IFB.**

**Question 17:** Page 1 of the IFB indicates Deadline for Submission is Friday, June 14, 2024, on or before 2:00PM. Page 3 of the IFB indicates Electronic Copy and Original Copy with Original Bid Security must be received by the Procurement Office no later than 2:00 PM Monday, June 10, 2024. Please clarify the bid submission date and time.
