Minimum Qualifications:

- Bachelor's degree in relevant field from a U.S. regionally accredited institution;
- One (1) year experience relevant to the position <u>OR</u> combination of college credits, technical training, and/or substantial professional level work experience;

Preferred Qualifications

- Three (3) years of experience working with dog handling;
- One (1) year of experience conducting invasive species surveys and management;
- Background or experience in invasive species management work;

Character of Duties:

Incumbent will serve as the Project Associate for the Department of Agriculture, Biosecurity Division and will supervise a small pilot project utilizing detector dogs to conduct surveys of invasive species in project areas with guidance from the Principal Investigator.

This includes, but is not limited to:

- Building and maintain canine kennels;
- Training handler-dog terms;
- Managing workflow of work unit;
- Ensuring the wellbeing of working dogs, including but not limited to feeding, washing and maintain health records;
- Ensuring maintenance of dog terms proficiency;
- Coordinating inspections with government officials and private stakeholders;
- Record and compile data in the field;
- Assists in education and outreach activities as required;
- Maintain equipment inventory;
- Data analysis;
- Other duties as assigned;

Required Documents:

To validate credentials you may claim, (e.g., High School Diploma, College Transcript, etc.), an original or certified copy of the document(s) must accompany the application. Failure to provide proof may result in your disqualification. A selected candidate must provide official transcripts prior to hire date.

Police and Court Clearance:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.

Work Eligibility:

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.
- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.
- Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The Research Corporation of the University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position with the Research Corporation of the University of Guam, you will be required to present valid documents to comply with this law.

The Research Corporation of the University of Guam complies with Public Law 24-109 in reference to the provisions and requirements of the Americans with Disabilities Act.
