- Bachelor's degree in Biology or related field from a U.S. regionally accredited institution or foreign equivalent;
- One (1) year of experience relevant to the position <u>OR</u> combination of college credits, technical training and/or substantial professional level of work experience;

#### **Preferred Qualifications:**

- Can operate a Trimble Geo 7X handheld;
- Horticultural experience;

# Minimum Knowledge, Abilities, and Skills:

- Ability to identify plant and invertebrate species of Guam and the Northern Mariana Islands:
- Ability to hike through field and difficult terrain in all weather conditions with field gear that weighs up to 50 pounds;
- Ability to communicate effectively;
- Strong verbal and written skills;
- Ability to manage time efficiently and ability to prioritize work;
- Ability to work flexible hours, including weekends and evenings, as needed;

## **Character of Duties:**

- Identify plant and invertebrate species of Guam and the Northern Marianas Islands;
- Conduct field surveys;
- Use basic field data collecting tools, such as field compass, topographic maps, clinometer, global positioning systems, use recommended software for data entry and analyses;
- Collect propagules and propagate plants in the nursery;
- Outplant plant material from nursery to the field;
- Manage and maintain the nursery and outplanting sites;
- Follow protocols for collection and management, and prevention of alien species seed dispersal by field crews;
- Follow safety program and security procedures;
- Participate in trainings and meetings;
- Assist with reporting to funding agencies, including data collection and writing;
- Assist with the development of plant field guides and posters;
- Conduct scientific review of literature;
- Perform data analysis when needed;
- Assist in the preparation of field activities;
- Perform other duties as assigned;

#### Note:

The selected candidate is or can be added to the list of authorized individuals on a Section 10(a)(1)(A) recovery permit from the USFWS to collect, manage, propagate, and outplant native federally listed species (particularly plants and invertebrates). If the selected candidate is not on a

list of authorized individuals on a Section 10(a)(1)(A) recovery permit upon contract award, the technician must submit a request to USFWS be added to a list of authorized individuals on a Section 10(a)(1)(A) recovery permit within two weeks after employment.

#### **Police and Court Clearance:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances

<u>Selected candidate</u> must provide official transcripts prior to hire date.

#### **Work Eligibility:**

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.
- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.
- Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The Research Corporation of the University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position with the Research Corporation of the University of Guam, you will be required to present valid documents to comply with this law.

The Research Corporation of the University of Guam complies with Public Law 24-109 in reference to the provisions and requirements of the Americans with Disabilities Act.
