### **Minimum Qualifications:**

- Master's Degree in Environmental Science from a U.S. regionally accredited institution or foreign equivalent;

### **Preferred Qualifications:**

- Field experience in groundwater data collection;
- Familiarity with USGS data collection protocols;
- Knowledgeable in hydrogeology of the Northern Guam Lens Aquifer (NGLA);
- Familiarity with water well design, drilling, construction, sampling, and testing;
- Experience in geospatial analysis and map preparation;

### **Character of Duties:**

- Assist the WERI Director and faculty: Report directly to the WERI Director and work with designated WERI faculty to prepare plans, budgets, and reports related to *Comprehensive Water Monitoring Program (CWMP)* and *One-Guam Aquifer Monitoring Program (OGAMP)* implementation and management; consolidate and analyze CWMP and OGAMP data on groundwater quantity and quality to support status reports, trend analyses, policy and management recommendations, and ongoing scientific and engineering studies of the NGLA.
- Represent WERI at interagency MSERP and OGAMP technical meetings: Provide technical support to the *Monitoring System Expansion and Rehabilitation Project (MSERP)*. Attend MSERP meetings and meetings of the Technical Experts Group established under the 7 December 2016 ONE-GUAM MOU and other venues to contribute technical expertise on rehabilitation of existing wells; construction and testing of new deep observation wells; maintenance of NGLA observation wells and associated infrastructure.
- Coordinate with GWA: Contribute technical expertise and historical information to discussions and decisions relating to design, construction, configuration, servicing, maintenance, repair, and operation of CWMP wells and any other hydrologic data collection facilities; coordinate interagency information-sharing and actions.
- Coordinate with NAVFACMAR: Contribute technical expertise and historical information to discussions and decisions relating to design, construction, configuration, servicing, maintenance, repair, and operation of OGAMP wells and any other hydrologic data collection facilities; coordinate interagency information-sharing and actions.
- USGS-WERI geophysical field investigations: Coordinate and assist USGS and WERI scientists and technicians in collecting geophysical profiles from new OGAMP wells.
- USGS-WERI CWMP data collection: Work with USGS hydrologists and WERI personnel to carry out routine (e.g., quarterly and semiannual) data collection following USGS protocols on Guam water resources, including groundwater levels and conductivity profiles in deep observation wells.
- WERI NASA-ACTUAS PROJECT SUPPORT: Work with principal investigators and student research assistants on WERI's collaborative project, *Autonomous Control Technology for Unmanned Systems with Agricultural and Environmental Applications in Pacific Islands (ACTUAS)*, to maintain equipment; configure and calibrate instruments;

help train student research assistants to plan and prepare for fieldwork; assist in analyzing and interpreting data; prepare manuscripts for submission to professional journals; present research results at professional meetings; and support STEM outreach activities.

**Police and Court Clearance:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances

**Selected candidate** must provide official transcripts prior to hire date.

**Work Eligibility:**

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.
- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.
- Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The Research Corporation of the University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position with the Research Corporation of the University of Guam, you will be required to present valid documents to comply with this law.
