**Character of Duties:**

The selected candidate will be responsible to refer and inform the geriatrics and ADRD population to community resources and programs offered on island such as services, community programs, legal aide, and other healthcare providers available. This includes, but is not limited to:

- Develop recreational content and resource materials for caregivers, and different stages of aging for the elderly population;
- Perform administrative duties such as design data forms for collection, create meeting minutes and agenda, and maintain GWEP files and data collected for the annual reports, and research and fulfill procurement duties as needed;
- Manage social media content such as developing marketing and informational content, and uploading to the G/M GWEP social media accounts;

court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.

- Applicants accepting employment or volunteer work with educational institutions and/or agencies requiring a health clearance must take and pass a pre-entry and annual Tuberculosis Test as a condition of employment.
