- Must be comfortable handling and caring for medium to large canines;
- Possess an interest, background or experience in invasive species management work;
- Possess basic computer skills;
- Possess excellent coordination skills'
- Ability to lift and carry up to 60 pounds;
- Ability to walk five (5) miles a day in various weather conditions, including uneven terrain;
- Ability to communicate effectively, both orally and written;
- Ability to work independently and as a member of a team;
- Ability to manage time efficiently and ability to prioritize work;
- Ability to travel to and from kennel facilities on weekends;
- Ability to work flexible hours, including weekends and evenings, as needed;

Character of Duties:

Incumbent will serve as a Detector Dog Handler for the Department of Agriculture, Biosecurity Division and will utilize a detector dog to conduct surveys of invasive species in project areas with guidance from the Principal Investigator.

This includes, but is not limited to:

- Pass a background check and obtain credentials to access ports of entry and maintain throughout the duration of employment;
- Pass a 9-week detector dog handler course and maintain annual re-certification throughout the duration of employment;
- Handle a canine trained to detect invasive species at the ports of entry, which includes conducting inspections outdoors and in warm locations for extended periods of time;
- Ensure the wellbeing of working dogs (e.g. feeding, grooming, and exercising) on a daily basis, including some weekends;
- Maintain clean and sanitary kennel facility on a daily basis, including some weekends;
- Keep accurate and detailed records of training and canine activities;
- Coordinate inspections with government officials and private stakeholders;
- Conduct invasive species inspections and surveys;
- Record and compile data in the field;
- Maintain equipment inventory;
- Assist in education and outreach activities as required;
- Assist in facility yard maintenance;
- Other duties as assigned;

Police and Court Clearance:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances

Work Eligibility:

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.
- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Applicants accepting employment or volunteer work with educational institutions and/or agencies requiring a health clearance must take and pass a pre-entry and annual Tuberculosis Test as a condition of employment.
