Minimum Qualifications:

- Bachelor's degree in Public Health, Nutrition, Environmental Sciences or other related field from a U.S. regionally accredited institution or foreign equivalent;

- One (1) year of work experience relevant to the position;
- Must possess a valid driver's license;

Preferred Qualifications:

- Experience in community research or project coordination;

Minimum Knowledge, Skills, and Abilities:

- Proficient in Microsoft Office and the Google Suite Package;
- Demonstrate oral and written communication skills;
- Be a self-starter and prepared to learn and follow protocols and be attentive to details;
- Familiar with the policy, systems, and environmental approaches to child health, food systems, and community development in the Pacific region;

Character of Duties:

- Assists in the planning, management, implementation and reporting of food system and child health related research activities in research and community settings;
- Conducts data collection project monitoring, and research dissemination throughout Guam;
- Recruits and conducts interviews with community leaders and food system and child health experts in the community (on- and off-campus);
- Collects and enters research data into the computer or onto data forms and verifies data;
- Assists in analyzing test data, recording observations and measurements and preparing recommendations;
- Specific duties will be dependent on current project needs and other duties as assigned;
- Duties may also include supporting other related activities within the Children's Healthy Living Food Systems grant;

Police and Court Clearance:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.

Work Eligibility:

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- The selected candidate must provide proof of education credential claimed (High School diploma, College Transcript) on the application.
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition,

the applicant releases previous employers and job-related sources from legal liability for the information provided.

- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Applicants accepting employment or volunteer work with educational institutions and/or agencies requiring a health clearance must take and pass a pre-entry and annual Tuberculosis Test as a condition of employment.
- Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The Research Corporation of the University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position with the Research Corporation of the University of Guam, you will be required to present valid documents to comply with this law.

The Research Corporation of the University of Guam complies with Public Law 24-109 in reference to the provisions and requirements of the Americans with Disabilities Act.
