# **Character of Duties:**

Research Associate II hired under this announcement will be part of the Brown Treesnake Project (BTS) under the direction of U.S. Geological Survey (USGS) scientists and work in close collaboration with National Park Service and U.S. Fish and Wildlife Service personnel to develop a citizen science program. As coordinator you will help design and implement highquality research on biology, control, and containment of the brown treesnake with the eventual goal of restoring native species. Develop plans to address other potential predators of avian species. Offices and labs are at the Guam National Wildlife Refuge, Ritidian Point, Yigo, Guam, and fieldwork will occur at Asan Beach Unit, War in the Pacific National Park. Project leaders are based at the War in the Pacific National Historical Park, Guam National Wildlife Refuge, and at the USGS Fort Collins Science Center.

- Develop and coordinate a Citizen Science and crowdsourcing program for BTS removal and avian recovery;
- Conduct outreach with local communities to build a network of Citizen Science volunteers;
- Provide leadership, motivation, and engagement with community volunteers;
- Obtain permits and knowledge of protected species and how to work within sensitive habitats;
- Setting and checking traps and other control tools for BTS and other invasive species;
- Conducting capture, animal measurements, humane euthanasia, and necropsy of brown treesnakes and other species;
- Write standard operating procedure and project documents;
- Design snake and other avian pest removal strategies with researcher guidance;
- Manage data from multiple sources;
- Coordinate with multi-agency field efforts;
- Provide weekly summaries;
- Other duties assigned;

# **Police and Court Clearance:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances

# Work Eligibility:

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.
- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Applicants accepting employment or volunteer work with educational institutions and/or agencies requiring a health clearance must take and pass a pre-entry and annual Tuberculosis Test as a condition of employment.
