



GUAM CANCER TRUST FUND COUNCIL MEETING MINUTES OF August 20, 2020

I. CALL TO ORDER

- Dr. Rachael Leon Guerrero called the meeting to order at 3:04 p.m.
- Minutes of previous meeting tabled until next meeting

Motion Approved by: R. Yamanka, K. Leon Guerrero

II. REPORT FROM THE CHAIR

- Work on GCTF Rules and Regulations during COVID
 - a. Council has continuously worked to review rules and regulations
 - b. Then forwarded to UOG legal counsel for review
 - c. Final copy to be approved in "Old Business" portion of meeting
- Change in personnel (accounting technician)
 - a. Newly hired accounting technician to start 08/24/2020
 - b. R. Yamanka will discuss further in her report
- Financial Report
 - a. According to July 31st financial report:
 - We have received \$833,333 of allotment from GovGuam. Currently up-to-date through July 2020
 - b. Extra half million supposed to be given by legislature for FY2020
 - Did not happen due to COVID
 - Arrangement to have funds be taken from another entity's budget
- Governor's budget and Legislature's budget allocation for FY 2021 both proposed only \$1 million
 - a. Distributed \$2,684,300 in FY2020
 - b. FY2021 projections for Health Futures Fund is about \$41 million
 - c. Letter sent to 35th Guam Legislature to consider increasing allocation to \$2.5 million (only 6% of HFF)
 - HFF projected to bring in \$41 million
 - Needed b/c \$2 million distributed in FY2020
 - Smaller amounts allocated to applicants
 - One senator confirmed to have received email (R. Leon Guerrero)
 - Email confirming received from 4 out of 15 senators (C. Castro)
 - d. Might have to strategize to deal with shortfall
 - Lack of funding might affect all organizations

III. REPORT FROM GCTF PROGRAM MANAGER

- Emails sent FY2020 application guidelines sent to the following organizations:
 - a. American Cancer, Ayuda Edward, Guam Cancer Care, Guam Memorial Hospital, and Claire Camacho (UOG)

- i. Recommended to forward emails to these organizations
- c. FY2020 invoices up-to-date for following organizations:

 - ii. American Cancer Society
- d. Pending invoices from Guam Cancer Care and Ayuda Foundation
 - i. Mr. Espaldon asked for non-cost extension for his program
 - Will be discussed further and might need a written request (R. Leon Guerrero)
- e. New application with updated guidelines to be sent to all former applicants

 - i. Motion followed by all other attending parties
- Deadline for grant applications for FY2021 set for Sept. 1, 2020

 - i. Tentative 30-day extension (K. Leon Guerrero)
 - Offered upon request (30-day limit not disclosed)

V. NEW BUSINESS

- Next step for rules and regulations
 - a. Public hearing
 - i. UOG sponsored
 - ii. Those interested will be forwarded link and pdf draft of rules and regulations
 - iii. Regulations set at 10 working days
 - Possible dates to be set in September
 - Confirm date with T. Krise in order to advertise (possibly Labor Day week)
- Request to reallocate funds for American Cancer Society approved
 - a. Forma letter to be prepared and sent to organization

VI. OPEN DISCUSSION/ INFORMATION

- Organizations inquiring if affidavits are required applications (M. Artero)
 - a. Requirement not stated in regulations or guidelines
 - b. Further clarification from legal counsel to be requested
 - c. Asked to have notary requirement be waived due to current COVID conditions
- Formal request sent to re-work budget spending due to current COVID situations (M. Artero)
 - a. Advised to prepare and submit a written request explaining changes in funds uses
 - b. Formal letter prepared and submitted
 - i. Request approved
