You are required to submit a 1500-2000-word reflection paper due on **June 17.** In this reflection paper, you will identify and research a pressing problem in the US Government about which you feel strongly and come up with a solution. This can either be in the form of a newspaper column/essay or a formal letter to the US President. As

- 2. The content of the bill you chose. How is the bill effective in addressing the issue/problem you identified?
